

REMARKS

On the early afternoon of 16 November 2014, the Air Accident Investigation Department was notified of a serious incident in DelMonte Farm in Gatuanyaga near Ndula Marker. The aircraft, a Cessna U206 of registration 5Y-CFB, was on a private flight from Wilson Airport to Murgi Ranch in Laikipia. The pilot was the sole occupant in the aircraft. According to the pilot, the aircraft was refueled at Wilson Airport with 90 gallons of fuel and the engine was topped up with two quarts of oil. According to the pilot, preflight and power checks conducted prior to the flight indicated that everything was normal.

The aircraft took off from Wilson Airport at approximately 0858 hours. Just after take-off, the aircraft changed route to NE due to weather. At approximately 0905 hours, the pilot noticed that the fuel flow had dropped from the initial setting of 14 to 13 gallons per hour. Upon readjustment, the pilot stated that the fuel flow again dropped from 14 to 13 gallons per hour. At approximately 2 nautical miles from Ndula Marker, the pilot reported hearing a thud noise followed by loss of engine power. The oil filler cap door opened and oil started oozing. The aircraft lost oil pressure and at approximately 0915 the pilot made an emergency landing at an empty road inside DelMonte Farm.

The damage sustained by the aircraft was limited to the engine and engine cowling. Preliminary examination of the aircraft engine revealed an internal structural failure of cylinder N = 4 connecting rod and a section of the crankcase. A small section of the engine cowling was also torn.

The pilot did not sustain any injuries as a result of the incident.

The investigation is in progress.
